## FUND OBJECTIVES

The aim of the IFSL Mazarin Adventurous Fund (the 'Fund') is to provide capital growth, that is, to increase the value of your investment, over a minimum of 5 years. The Fund aims to have an average yearly volatility (a measure of the size of short-term changes in the value of an investment), below 15% per year, over any 5-year period. This may limit the potential for capital growth.

There is no guarantee that the Fund will meet its investment objective or volatility target, and investors may not get back the amount originally invested. At least 70% of the Fund's assets will be invested in other collective investment schemes, closed-ended funds and exchange-traded funds.

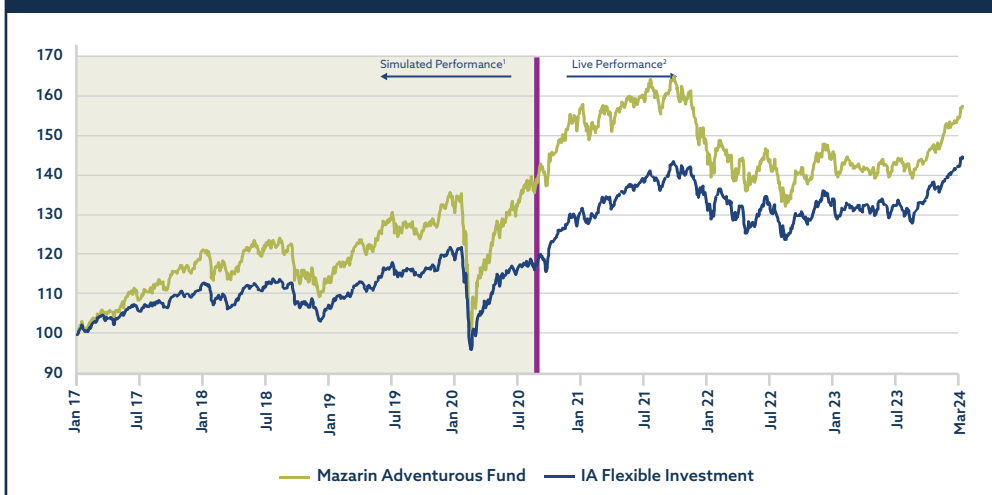
